Reference Guide:-

All adults who intend to occupy the property are required to complete an application form and provide referencing paperwork. Referencing paperwork must be supplied within 5 days of the application form being completed.

Applicants are required to provide: -

- photographic ID (passport or driving licence)
- proof of their current address (utility bill, bank statement or driving licence)

Applicants are also required to provide all of the following that are appropriate to their circumstances:

- recent landlord/letting agent reference stating tenancy dates, monthly rent due, details of any
 arrears, a statement on the condition of the property during or at the end of the tenancy and a
 statement on whether there were any breaches of the tenancy agreement;
- employer/pension provider/accountant reference on headed paper stating job title, contract length and annual income;
